

## State and local sales tax revenue documentation

This dataset provides northeastern Illinois data from July 1999 to December 2020 pulled from the Illinois Department of Revenue, <https://www.revenue.state.il.us/app/kob/index.jsp>. The data provides revenues by calendar year quarter of sale, for each tax type and disbursement type.

Fields:

Place – jurisdiction where the tax revenue was generated, either an incorporated municipality, or, when the place is listed as a county government, this means that the tax was generated in an unincorporated area of that county.

County – county where the tax revenue was generated
